

“ALLOGGIO ESTIVO – SUMMER ACCOMMODATION” NOTICE A. Y. 2025/2026

- pursuant to the Director Decree no. 147 of 12 May 2026 -

1. PERIODS

24 July 2026 – 18 September 2026

or

24 July 2026 – 21 August 2026

or

24 August 2026 – 18 September 2026

Requests for accommodation for periods after 18 September 2026 will not be taken into consideration.

Beds will be allocated in the manner described in section 6.

3. WHO CAN APPLY FOR ACCOMMODATION

- Students, PhD and post-doctoral students enrolled at the University of Padua, at the Conservatories of Music of Adria, Castelfranco Veneto, Padua, Rovigo, Vicenza and at the High Schools for Linguistic Mediators of Vicenza (Belluno and Vicenza campuses) and CIELS (Padua and Milan campuses), and assignees of accommodation at the ESU residences for the academic year 2025/2026, who have not completed their career as of 24/07/2026 and **who have paid the accommodation fees due for the academic year 2025/26 on the date of sending the accommodation offers;**

- Students enrolled at the institutions listed above or enrolling for the 2026/27 academic year or participating in international incoming mobility programmes to Padua during the 2025/26 or 2026/27 academic years.

4. HOW TO APPLY FOR ACCOMMODATION

Interested students must complete the application electronically on the website <https://myesupd.dirittoallostudio.it> by logging in with their credentials/SPID, choosing the academic year 2025/26 and using the form "**Summer Accommodation Request - Summer Accommodation**" from 19 May 2026 at 10:00 am.

PLEASE NOTE: It will not be possible to choose a residence or room type. Those who prefer to be assigned one of the most affordable places can submit a ticket to express their preference by the offer submission date. Other preferences will not be considered.

5. CRITERIA FOR HOUSING ALLOCATION

Priority in the allocation of accommodation will be determined according to the following criteria:

1. chronological order (date and time the application was sent);
2. accommodation requests for the entire period 24 July - 18 September;
3. accommodation requests for the period 24 July - 21 August (first period) or 24 August - 18 September (second period).

6. SENDING ACCOMMODATION OFFERS

Accommodation offers will be sent according to the following schedule, after checking the status (see points 3 and 7) and the period for which accommodation is requested (see point 5), until all available places are filled.

New accommodation offers will be sent weekly from 14/07/2026, in case there are available places.

The accommodation offer is accepted by paying the requested rate for the entire period of the accommodation booking. Failure to pay by the deadline shall result in the renunciation of the accommodation.

Any non-acceptance of offers will allow the list of applicants to be scrolled down in subsequent allocations, until there are available places. Anyone who renounces a bed and subsequently requests it again will be placed at the end of the list of applicants.

PLEASE NOTE: Accommodation offers cannot be changed. Requests for transfers within the residence, between residences, or from a double room to a single room or vice versa will not be considered.

Admission to the accommodation entails the student's acceptance of the [General Rules for University Residences](#), and in particular respect for the accommodation assigned and the common areas, the prohibition on transferring, subletting or granting the bed to third parties, and the punctual release of the accommodation **by 9 a.m. on the last day of assignment.**

- **regional scholarships eligible, but non-beneficiaries**
- **eligible for accommodation**

will be allowed to pay for summer accommodation during the period 24/08/2026 - 18/09/2026 at a reduced rate.

For students with disabilities only: the double room rate will be applied both to the student and to any assistant person sharing the accommodation. If the student with disabilities does not request an accompanying person, they may be assigned to a double room for single use, subject to availability of places.

Assigned students must pay the entire fee due as accommodation fees via PagoPa at the Student Desk (<https://myesupd.dirittoallostudio.it>) by the accommodation offer deadline.

The **deposit** paid by students assigned to ESU residences during the period 20/09/2025 - 24/07/2026 and referring to the A.Y. 2025/2026 will be **retained** to cover the further stay during the summer period and will be released, net of any bank charges, at the end of that stay, after the conditions of the accommodation itself have been checked (ref. [General Rules for University Residences](#), art. 10).

8. BOOKING CANCELLATION POLICY

The amount paid to accept the accommodation will only be refunded if the cancellation is communicated by ticket to <https://myesupd.dirittoallostudio.it> by the latest:

- 10/07/2026, for bookings starting on 24/07/2025;
- 07/08/2025, for bookings of the second period only, starting 24/08/2025.

For this purpose, the student must enter the bank details of a SEPA area current account in the appropriate section of the Student Desk.

In the event of a cancellation communicated in a manner or time different from that specified above, the amount paid will not be refunded.

It will not be possible to return part of the paid rent, so in the event of a request to reduce the allocation period from 2 months to 1 month, the amount of tuition fees paid for the excess month will **not** be returned.

11. INFORMATION ON THE USE OF PERSONAL DATA (GDPR)

Pursuant to Article 13 of the European Regulation 2016/679 (GDPR), the data acquired in self-certification as well as those contained in the requested documentation are intended for the elaboration of the list of students interested in summer accommodation (L.R. n. 8/1998).

The provision of data is necessary for participation in the selection and failure to do so will result in exclusion.

The processing of personal data will be based on principles of correctness, lawfulness, transparency and protection of your rights.

The processing of data will be carried out in automated and/or manual form, in compliance with the provisions of Article 32 of the GDPR 2016/679 on security measures, by authorised persons and in compliance with the provisions of Article 29 of the GDPR.

Data subjects are granted the rights provided for in the Regulation, in particular: access to personal data; rectification/deletion/limitation of processing; objection and proposal of complaint (pursuant to Art. 77 of the GDPR) to the Garante per la protezione dei dati personali.

The data will be kept for the period of time necessary to achieve the purposes for which they are collected and processed, in compliance with the principles of lawfulness and minimisation, however for a period not exceeding 10 years.

Data will not be transferred outside the territory of the European Union.
