TO FILL IN THE APPLICATION YOU MUST HAVE:

- Pdf of a valid document (ID card, passport, driving licence)
- Photo in .jpg format with dimensions of 220x280 pixels, maximum 1 MB
- IBAN of your current account
- ISEE 2026 certificate for subsidised benefits for the right to university study from which to obtain ISEE and ISP - ISEE Parificato Universitario 2026 from which to obtain ISEEU and ISPEU indicators

ATTENTION: The accommodation application can be completed even if you do not yet have the ISEE/ISEE Parificato, which however must have been requested before the deadline for submitting the application. The "Completion of income data" section remains active even after the accommodation application has been closed. When the student receives the ISEE, he must complete the "Completion of income data" section. Until the student provides the ISEE data, the application cannot be evaluated. Only students who present the ISEE Parificato must upload it in pdf format in the "Upload documents" section. We invite you to read the Competition Notice and this tutorial carefully.

Once confirmed, the application - UNLESS IT IS NOT VALID - must be supplemented by accessing the areas:

- COMPLETION OF INCOME DATA 2025/2026 in which to enter the economic data taken from the ISEE statement for the DSU/ISEE Parificato Universitario
- UPLOAD DOCUMENTS in which to enter any required documents (e.g. ISEE Parificato Universitario)

The student may personally modify his/her application until the application deadline.

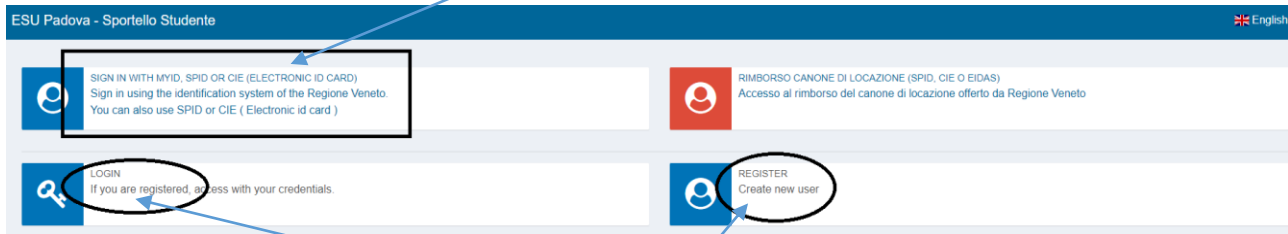

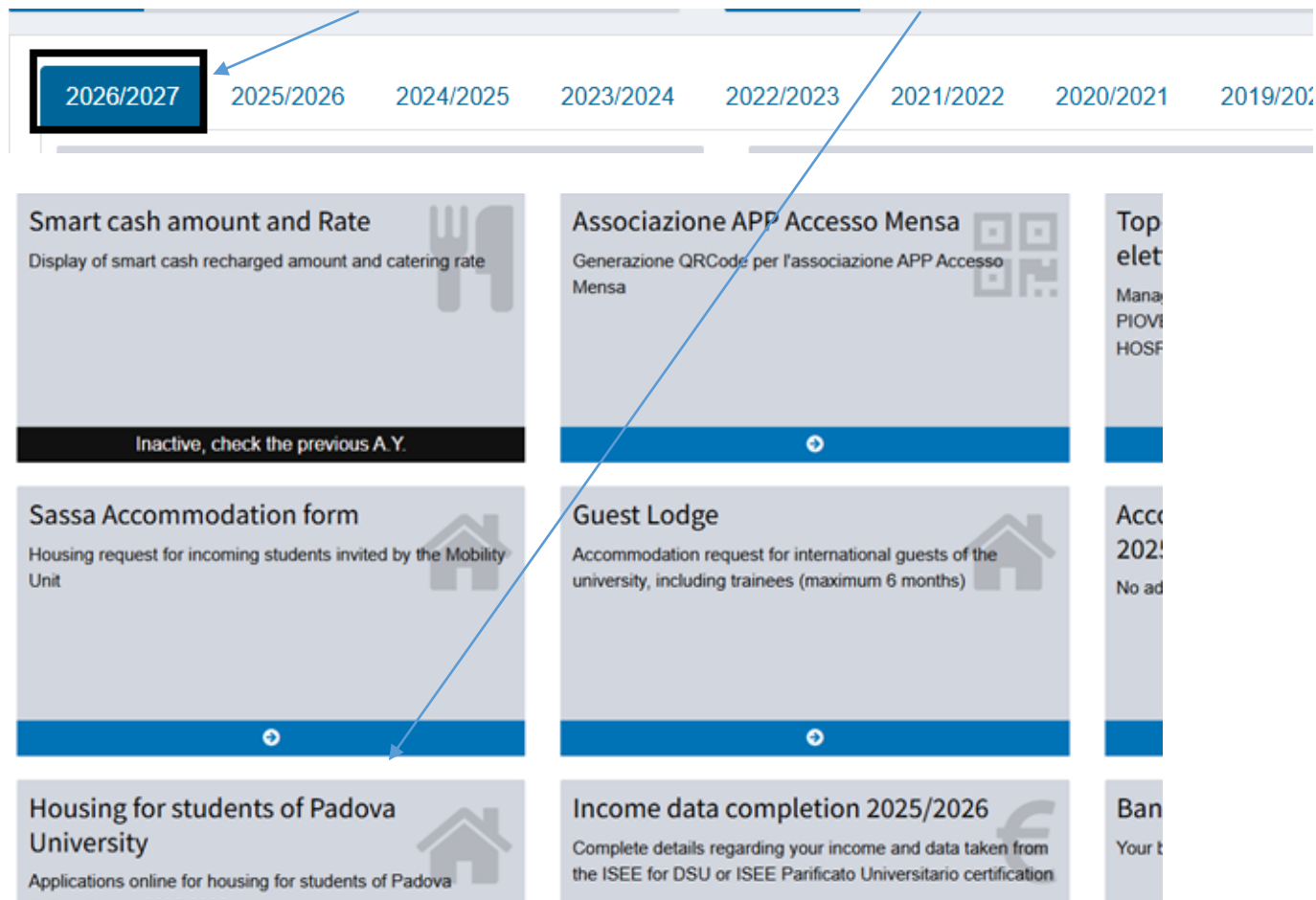
International students who are not in possession of a valid Italian identity document and residence permit cannot log in with SPID.

The DSU is a document that contains the personal, income and asset information necessary to describe the economic situation of the family unit for the request for subsidized social benefits. In practice it is a document that aggregates all the information which is then used to process the ISEE.

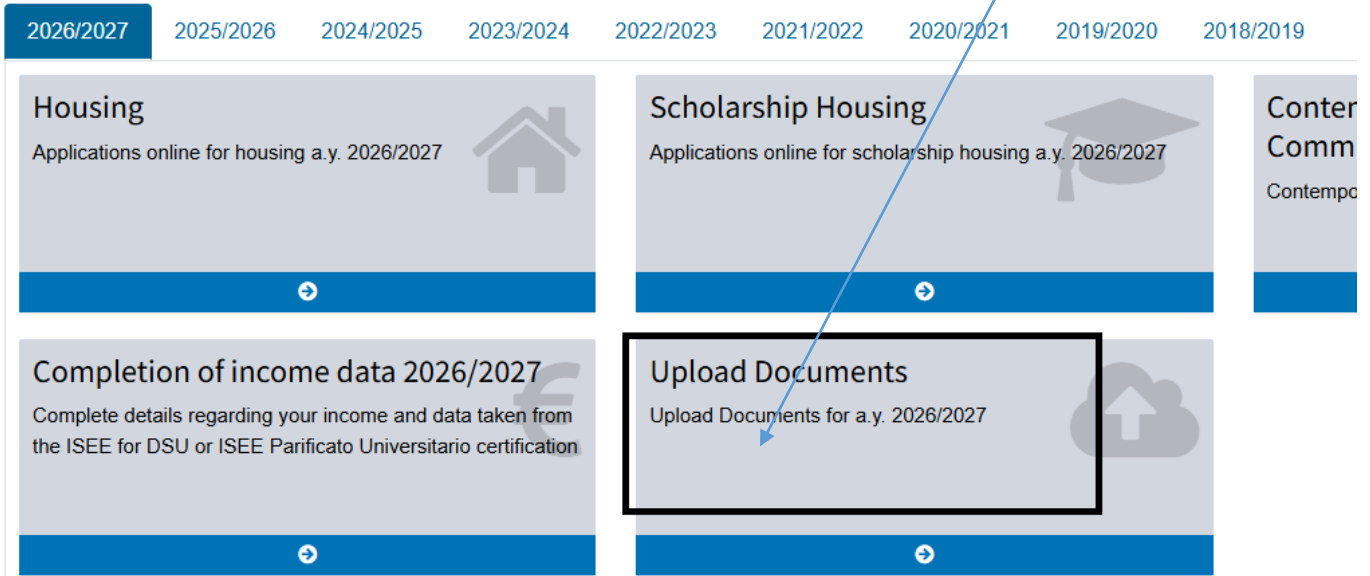

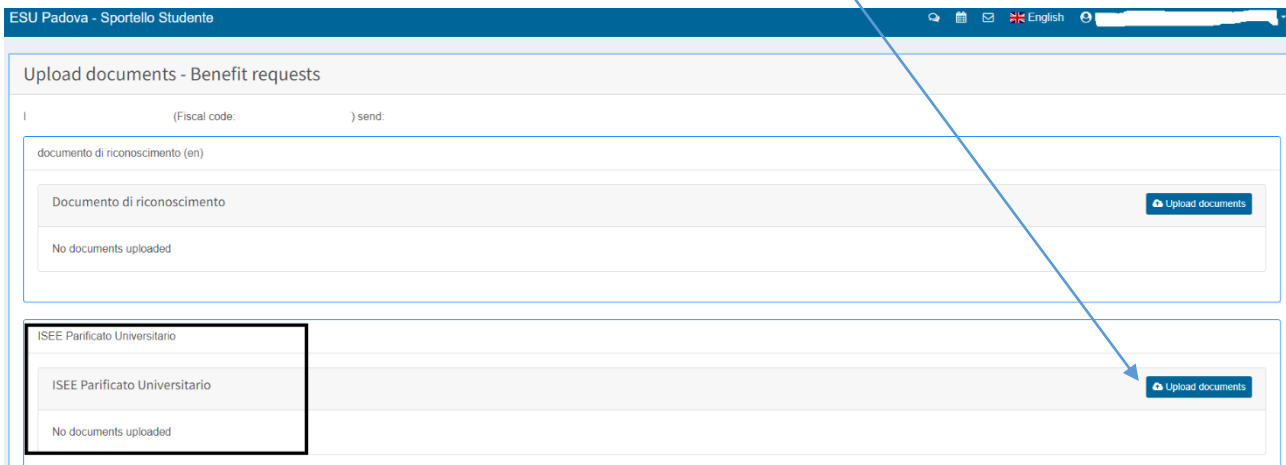
